## Ways to apply for Concessionary parking

- Apply online at [www.basingstoke.gov.uk/alenconparking](http://www.basingstoke.gov.uk/alenconparking)

Or

- Complete and return the form opposite to the address on the back of the form, enclosing a colour copy of both sides of the Blue Badge (if required we can photocopy your blue badge at Parklands Reception).

*N.B. If there are any changes in your circumstances, please notify Basingstoke and Deane Borough Council immediately.*

Once your application has been processed, you will receive a pass card allowing access to The Malls car park.

Blue Badge holders do not have to own a vehicle or be able to drive to have a pass card however **the pass card is only valid when the Blue Badge holder is present in the vehicle.** Checks will be made to ensure compliance.

If you have difficulty operating the pass card system, and if you are the only person who drives the vehicle, we can arrange for our system to recognise the vehicle number plate, the barriers will then be raised automatically on entry and exit.

### **Further Assistance within The Malls Car Parks**

Should you experience issues with your pass card, intercoms are located on all entry/exit barriers and pay stations to enable you to receive assistance from the car parking staff.
