ORDER 2011**

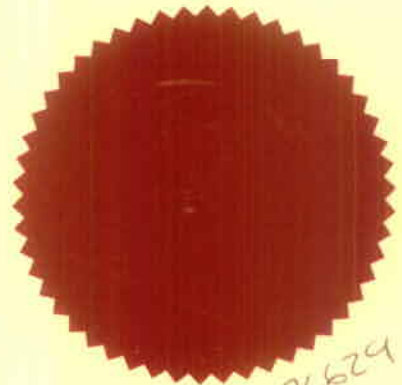
Basingstoke and Deane Borough Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of the powers of the said County Council and in exercise of the powers under Sections 84 (1) and (2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. To revoke the Order detailed in Schedule 1 to this Order, to the extent specified.

This Order shall come into operation on the 16th March 2012 and may be cited as "The Basingstoke and Deane Borough Council (Revocation of 30 Miles Per Hour Speed Limit) (C67 Newbury Road, Whitchurch) Order 2011

SCHEDULE 1
REVOCATION

The Basingstoke and Deane Borough Council (30 Miles per Hour and 40 Miles per Hour Speed Limits) (B3400 Church Street, C67 Newbury Road, C165 Winchester Road and The Weir, Whitchurch) Order 2007 in so far as it relates to the C67 Newbury Road between a point 121 metres north of its junction with Station Road and a point 216 metres north thereof; a total approximate distance of 216 metres.



Length of Newbury Road to revert to derestriction from 30mph

30mph and derestriction plates to be removed.
Gateway, including whitchurch fish sign to remain.

Proposed 30mph and derestriction signing and pos: TSRGD Diag 670 (30) facing southbound traffic and diag 671 facing northbound traffic
