

# Kempshott and Buckskin Ward Profile



## Population

The 2011 Census population of Kempshott and Buckskin was 10,435. The population had increased by 735 people since 2001, approximately 7.6%. Compared to an increase of 10.0% for Basingstoke and Deane.

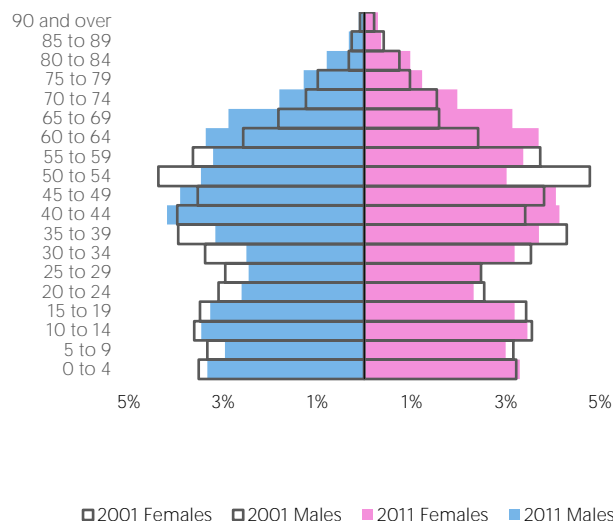


In addition to the usually resident population, there were 140 schoolchildren and students that lived outside the ward during term-time.

## Length of Residence

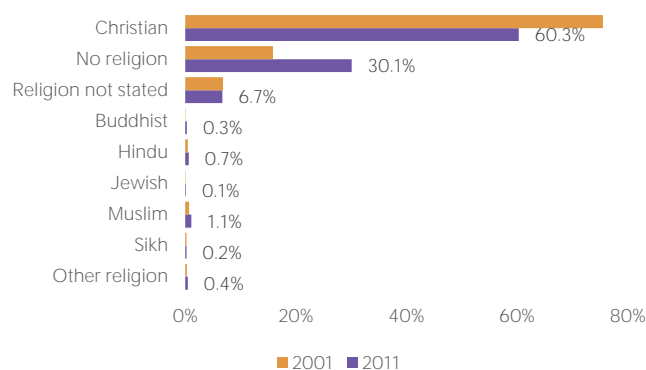
7.7% of the population were born outside the UK. 57.8% of these people had lived in the UK for 10 or more years.

## Age and Gender Profile



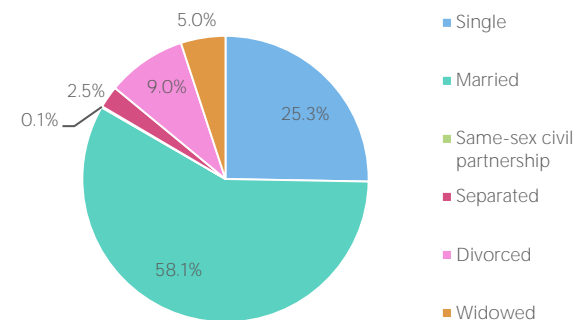
The population had aged since 2001. The percentage of the population aged 45 and over increased by 10.7%, whilst the population aged under 45 declined by 6.9%.

## Religion



The majority of residents were Christian (60.3%) but this figure had declined by 20.2% since 2001. Almost a third (30.1%) had no religion, which was an increase of 89.8% since 2001.

## Marital and Civil Partnership Status



The percentage of the adult population that were married declined by 5.4% over the decade. Compared to a 5.2% decline for Basingstoke and Deane. The percentage that were divorced increased by 24.4%.

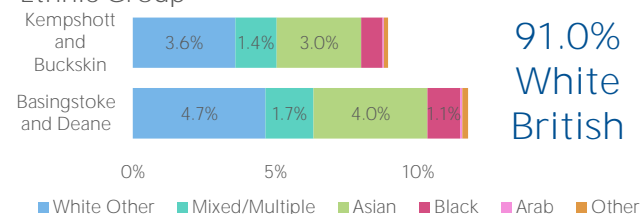

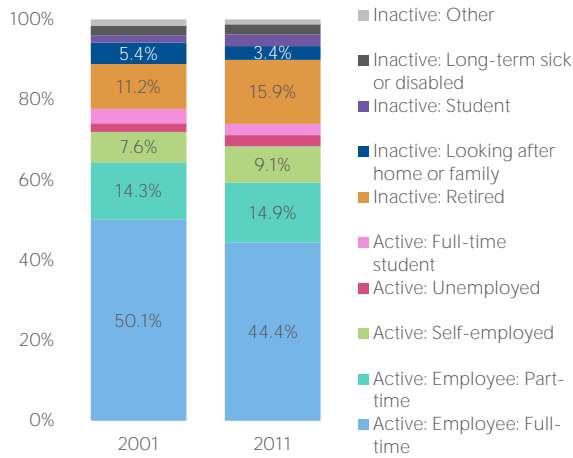

Non-White British ethnicities made up 9.0% of the ward's population (shown on the chart).

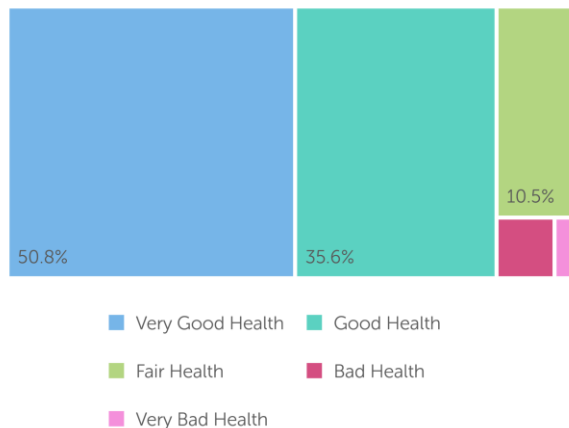


## Economic Activity



Under half (44.4%) of all residents aged 16-74 were working full-time in 2011, a decline of 11.5% since 2001. Those that were retired accounted for 15.9%, an increase of 43.0% since 2001. The percentage that were self-employed increased by 19.6%.

## General Health



50.8% of the population were in very good health and a further 35.6% were in good health. Of those with bad or very bad health (3.0%), 44.0% were aged 65 and over.

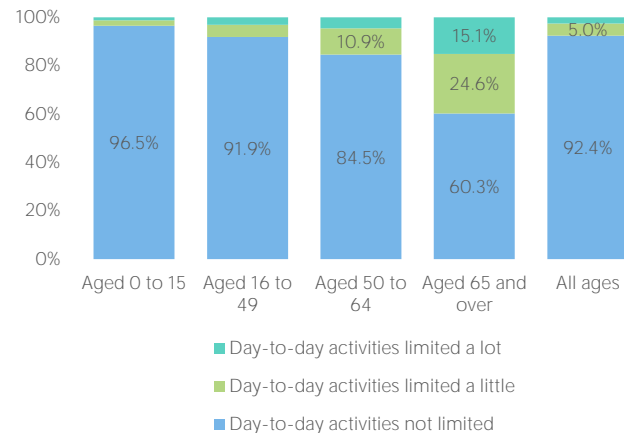
## Occupation

Top five occupations:

1. Administrative occupations (10.3%)
2. Corporate managers and directors (8.9%)
3. Science research, engineering and technology professionals (8.4%)
4. Elementary administration and service occupations (8.2%)
5. Business and public service associate professionals (7.2%)

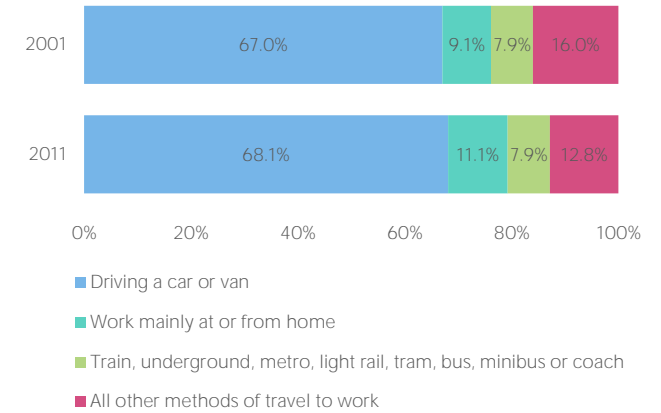
These top five occupations accounted for 43.1% of all the occupations in the ward. Since 2001, the percentage of the population employed in professional occupations (shown in blue) increased by 70.1%, whilst the percentage employed as managers, directors and senior officials (shown in purple) declined by 30.1%.

## Long-Term Health Problem or Disability



The percentage with a health problem or disability increased with age. 39.7% of those aged 65 and over had their day to day activities limited, compared to 45.3% across the borough.

## Method of Travel to Work



The majority (68.1%) of those aged 16-74 in employment drove a car to work. The percentage travelling by car increased by 1.6% since 2001. The percentage travelling by public transport increased (+1.0%), along with home working (+22.0%).

## Provision of Unpaid Care

- 10.1% of residents provided unpaid care (1,055 people) compared to 9.1% across the borough
- 17.4% of unpaid carers provided 50 or more hours of unpaid care a week (185 people) compared to 19.6% in the borough overall
- 20.7% of unpaid carers were aged 65 and over (220 people) compared to 20.3% in the borough as a whole

## Qualifications

17.0% of those age 16 and over had no qualifications.



## Dwellings

The number of dwellings in Kempshott and Buckskin in 2011 was 4,155. This was an increase of 505 dwellings since 2001, approximately 13.9%. Compared to 13.0% for Basingstoke and Deane and 8.9% for the South East.



In addition to dwellings, there were two communal establishments in the ward containing 10 people. These were care homes.

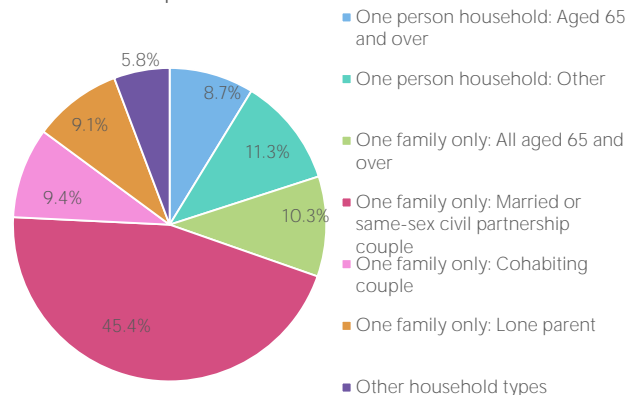

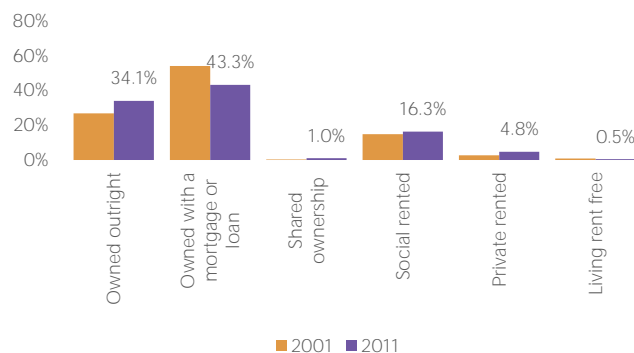
Over the decade, average household size declined from 2.67 to 2.55. Average household size was above the borough (2.40) and region (2.38) average. The average home in Kempshott and Buckskin had 6.2 rooms and 3.2 bedrooms, above the borough average (5.8 and 2.9).

## Household Composition



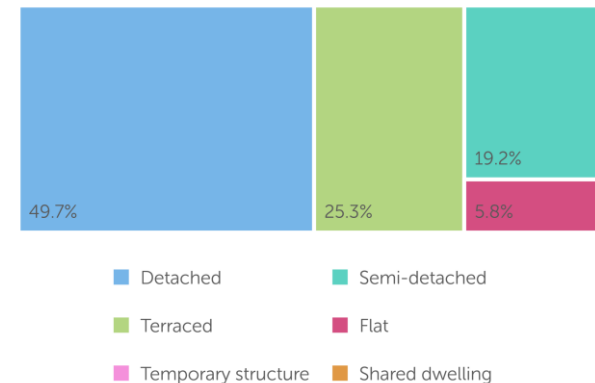
There were 4,085 households in Kempshott and Buckskin, housing 10,425 people. Many households were occupied by married or same-sex civil partnership couple households (45.4%). A fifth (20.0%) of households were lived in by those that live alone, an increase of 7.5% since 2001. 19.2% of households were occupied entirely by those aged 65 and over.

## Household Tenure



Over the decade, the percentage of households that owned their home with a mortgage declined by 20.1%. Outright ownership increased by 26.6%, whilst private renting grew by 75.3%. Shared ownership increased by 189.3%, which was an increase of 25 households.

## Accommodation Type



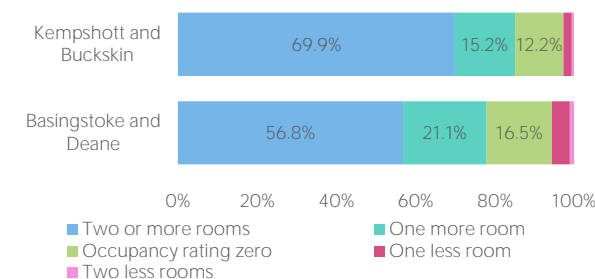
Many households lived in detached properties (49.7%). The percentage living in flats increased by 17.9% over the decade. The percentage living in houses and bungalows declined by 0.9%.

## Car Availability

11.8% of households had no access to a car or van, compared to 15.2% for Basingstoke and Deane as a whole. 3.4% had access to four or more cars or vans. There were 6,415 cars or vans.



## Occupancy Rating

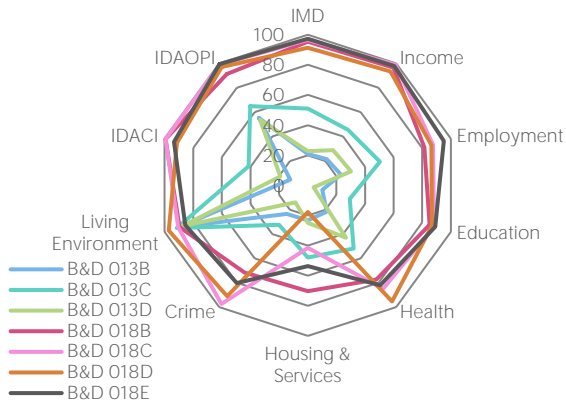


The majority of households had two or more rooms than they needed (69.9%).

## Indices of Deprivation, 2019



The chart shows Indices of Deprivation data for each domain and both IDACI and IDAOPI. It records how deprived each Lower Super Output Area (LSOA) in the ward was compared with all LSOAs in England. The closer each LSOA is to 32,844 (shown as 100), the lower the deprivation. B&D 013B, 013D and 013C were more disadvantaged than the other LSOAs in the ward (LSOA boundaries are shown on the ward map).

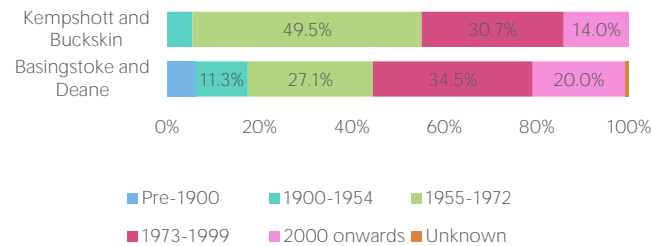

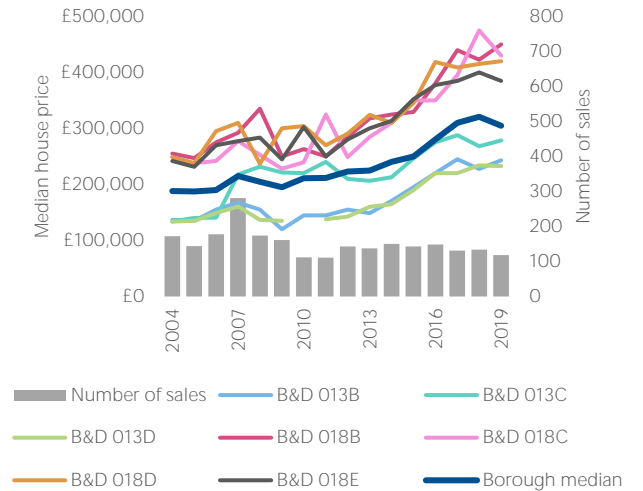


## Council tax property build period, 2020



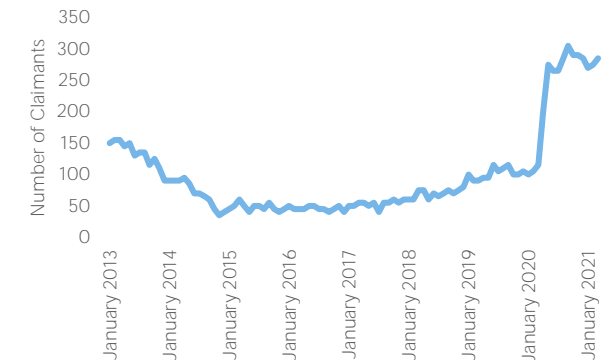
Kempshott and Buckskin had a larger percentage of dwellings built in the second half of the 20th Century compared to Basingstoke and Deane as a whole, with 49.5% built from 1955 to 1972, compared to 27.1% for the borough overall.

## House prices and sales, 2004-2019



There were 120 home sales in 2019, the lowest figure since 2011. This was 4.0% of the borough's house sales. One LSOA within the ward (B&D 018B) had a median house price in 2019 of £450,000, compared to the borough median of £305,000, and prices in this LSOA are consistently above the borough average.

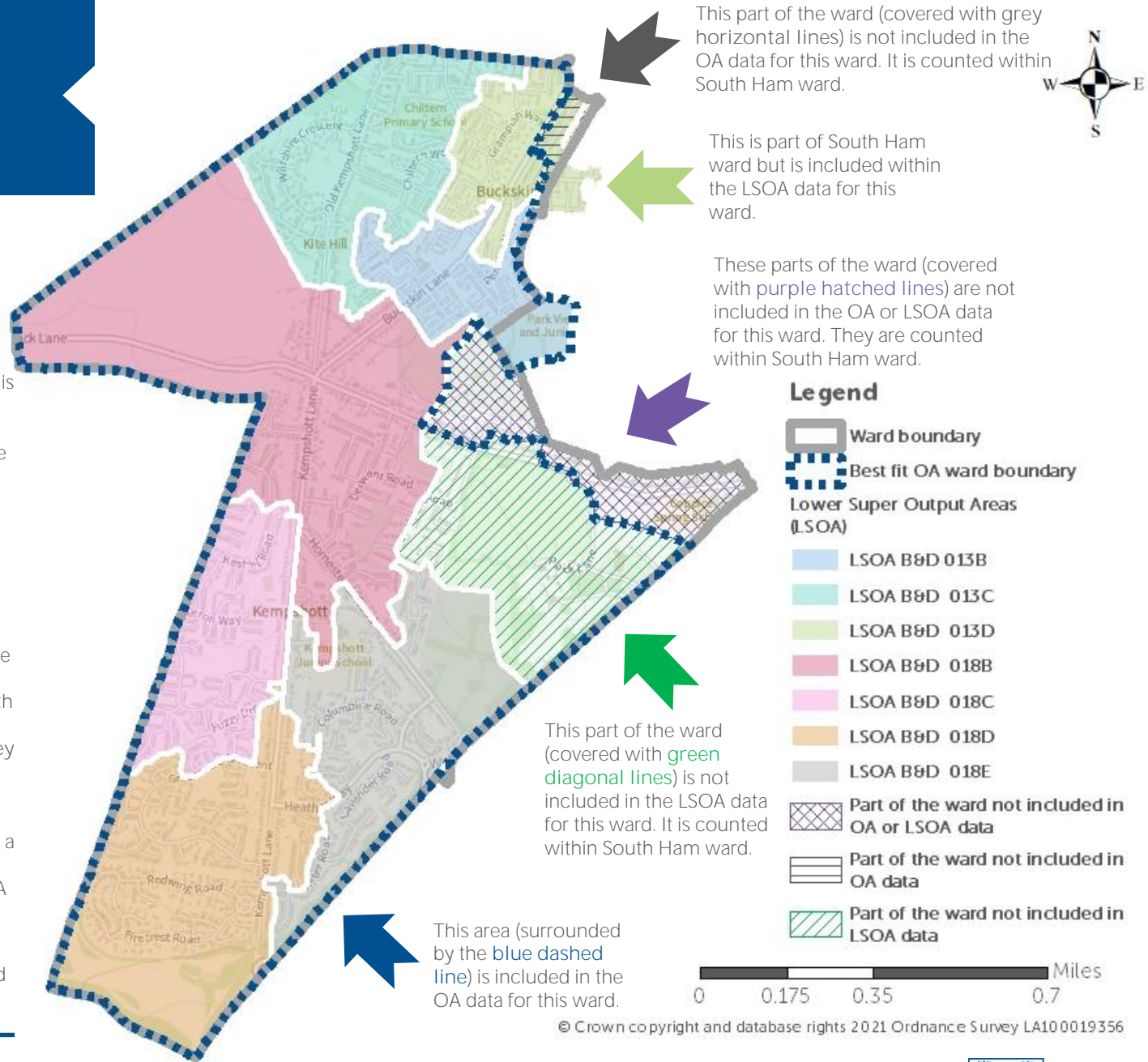
# Ward Map

The ward boundary is shown in grey.

Due to ward boundary changes, some data is only available for the area covered by the output areas (OAs) and lower super output areas (LSOAs) that best fit the ward area. The best fit output area boundaries are shown surrounded by the blue dashed line. Kempshott and Buckskin contains seven LSOAs and their best fit boundaries are shown with coloured backgrounds on the map.

An OA and LSOA is allocated to a ward if its population weighted centroid falls within the ward. This means that an area around Cornish Close (that actually falls within South Ham ward) is included within the ward's LSOA data. Edgell Close (covered with grey horizontal lines) is not included in the ward's OA data. An area around Pack Lane (covered with purple hatched lines) is not included in the ward's OA or LSOA data and a further area (covered with green diagonal lines) is not included within the ward's LSOA data.

The appendix shows which data is available for the ward boundary or the best fit OA and LSOA ward boundary.
