

Tadley North, Kingsclere and Baughurst Ward Profile



Population

The 2011 Census population of Tadley North, Kingsclere and Baughurst was 10,295. The population had decreased by 75 people since 2001, approximately 0.7%. Compared to an increase of 10.0% for Basingstoke and Deane.

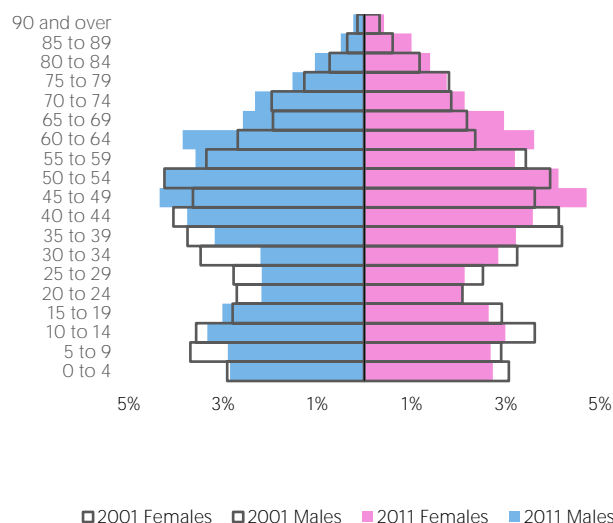

Length of Residence

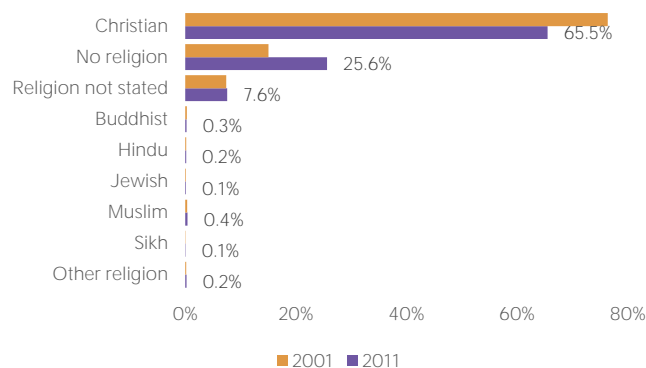
5.7% of the population were born outside the UK. 67.4% of these people had lived in the UK for 10 years or more.

Age and Gender Profile



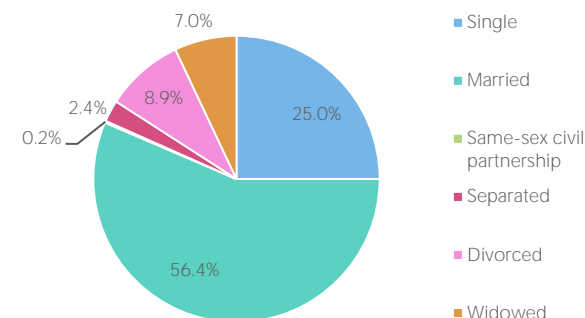
The population had aged since 2001. The percentage of the population aged 45 and over increased by 18.7%, whilst the population aged under 45 decreased by 13.4%.

Religion



The majority of residents were Christian (65.5%) but this figure had declined by 14.2% since 2001. A quarter (25.6%) had no religion, which was an increase of 70.1% since 2001.

Marital and Civil Partnership Status



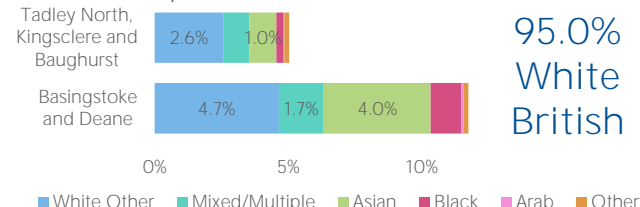
The percentage of the adult population that were married declined by 4.5% over the decade. Compared to a 5.2% decline for Basingstoke and Deane. The percentage that were widowed decreased by 6.1%.

Ethnic Group

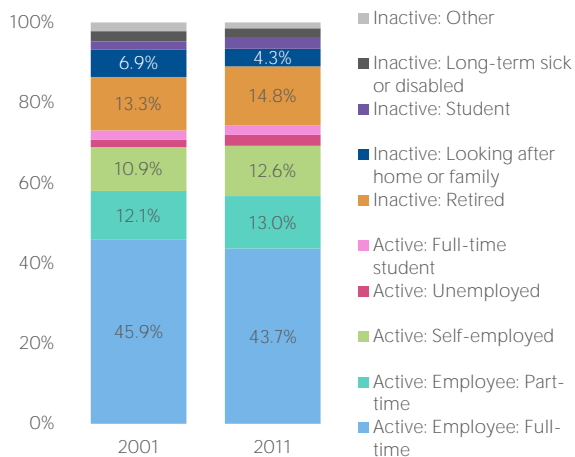

Non-White British ethnicities made up 5.0% of the ward's population (shown on the chart).

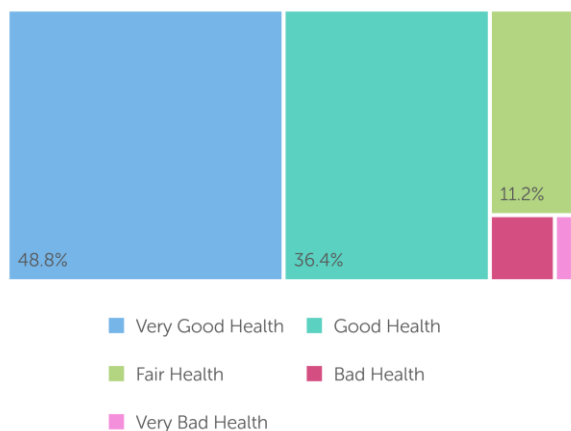


Economic Activity



Over two fifths (43.7%) of all residents aged 16-74 were working full-time in 2011, a decrease of 4.9% since 2001. Those that were retired accounted for 14.8%, an increase of 11.1% since 2001. The percentage that were self-employed increased by 15.8%.

General Health



48.8% of the population were in very good health and a further 36.4% were in good health. Of those with bad or very bad health (3.6%), 46.6% were aged 65 and over.

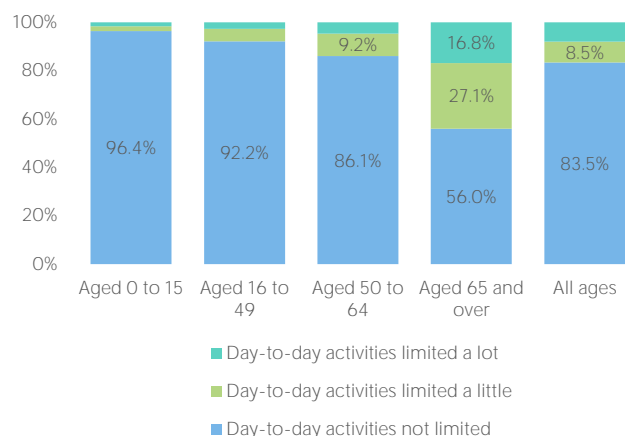
Occupation

Top five occupations:

1. Administrative occupations (9.0%)
2. Corporate managers and directors (8.7%)
3. Science research, engineering and technology professionals (8.1%)
4. Business and public service associate professionals (7.7%)
5. Elementary administration and service occupations (7.0%)

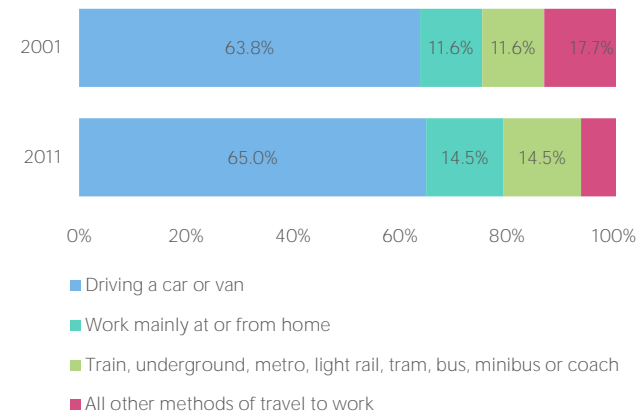
These top five occupations accounted for 40.5% of all the occupations in the ward. Since 2001, the percentage of the population employed in professional occupations (shown in blue) increased by 53.9%, whilst the percentage employed as managers, directors and senior officials (shown in purple) declined by 30.6%.

Long-Term Health Problem or Disability



The percentage with a health problem or disability increased with age. 44.0% of those aged 65 and over had their day to day activities limited, compared to 45.3% across the borough.

Method of Travel to Work



Over three fifths (65.0%) of those aged 16-74 in employment drove a car to work. The percentage travelling by car increased by 1.8% since 2001. The percentage travelling by public transport decreased (-16.8%), whilst home working increased (+24.7%).

Provision of Unpaid Care

- 9.8% of residents provided unpaid care (1,005 people) compared to 9.1% across the borough
- 19.6% of unpaid carers provided 50 or more hours of unpaid care a week (195 people) compared to 19.6% in the borough overall
- 22.5% of unpaid carers were aged 65 and over (225 people) compared to 20.3% in the borough as a whole

Qualifications

18.2% of those aged 16 and over had no qualifications.

Dwellings

The number of dwellings in Tadley North, Kingsclere and Baughurst in 2011 was 4,420. This was an increase of 185 dwellings since 2001, approximately 4.4%. Compared to 13.0% for Basingstoke and Deane.



In addition to dwellings, there were six communal establishments in the ward containing 85 people. These were medical and educational premises and hotels.

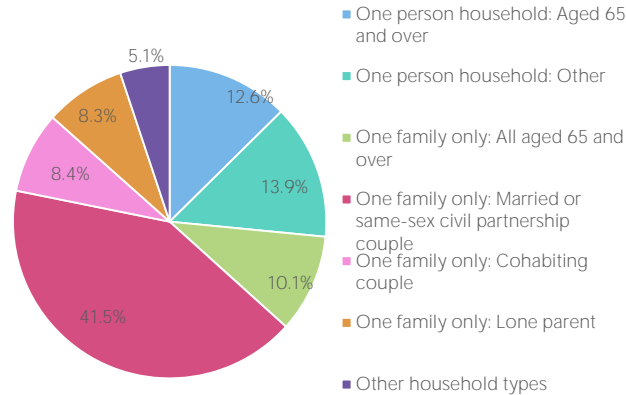

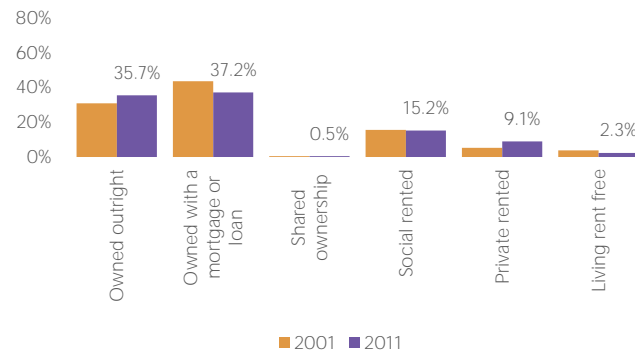
Over the decade, average household size declined from 2.47 to 2.37. Average household size was below the borough (2.40) and region (2.38) average. The average home in Tadley North, Kingsclere and Baughurst had 6.1 rooms and 3.1 bedrooms, above the borough average (5.8 and 2.9).

Household Composition



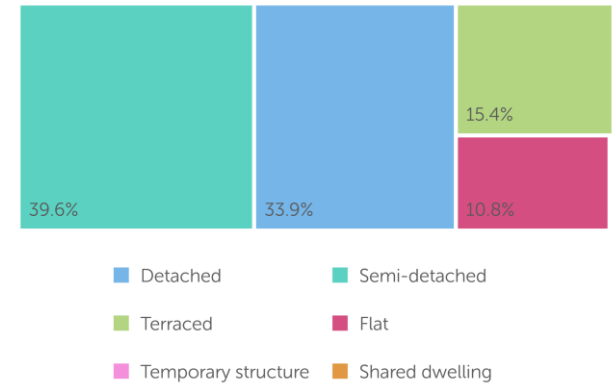
There were 4,305 households in Tadley North, Kingsclere and Baughurst, housing 10,205 people. Many households were occupied by married or same-sex civil partnership couple households (41.5%). Over a quarter (26.5%) of households were lived in by those that live alone, an increase of 7.1% since 2001. 23.0% of households were occupied entirely by those aged 65+.

Household Tenure



Over the decade, the percentage of households that owned their home with a mortgage decreased by 14.7%. Outright ownership increased by 14.9%, whilst private renting grew by 68.8%. Shared ownership increased by 17.7%, which was an increase of four households.

Accommodation Type



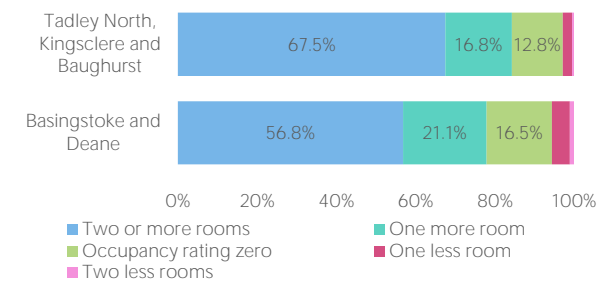
Many households lived in semi-detached properties (39.6%). The percentage living in flats increased by 20.5% over the decade. The percentage living in houses and bungalows decreased by 1.8%.

Car Availability

11.1% of households had no access to a car or van, compared to 15.2% for Basingstoke and Deane as a whole. 4.9% had access to four or more cars or vans. There were 7,120 cars or vans.



Occupancy Rating

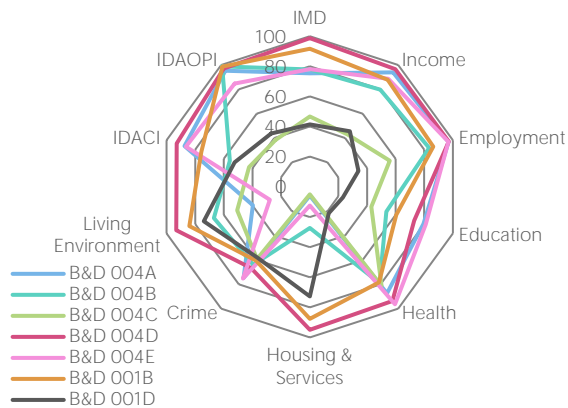


The majority of households had two or more rooms than they needed (67.5%).

Indices of Deprivation, 2019



The chart shows Indices of Deprivation data for each domain and both IDACI and IDAOPI. It records how deprived each Lower Super Output Area (LSOA) in the ward was compared with all LSOAs in England. The closer each LSOA is to 32,844 (shown as 100), the lower the deprivation. B&D 004C and 001D were more disadvantaged than the other LSOAs in the ward (LSOA boundaries are shown on the ward map).

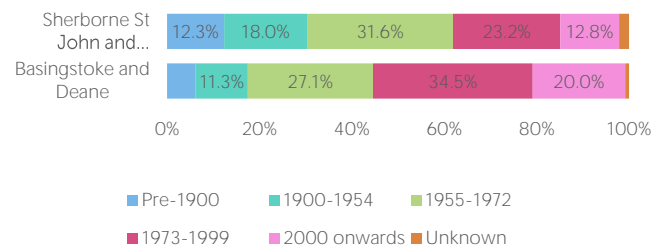

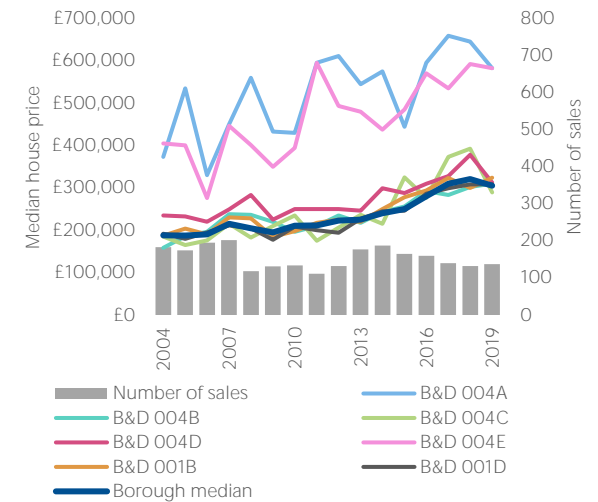


Council tax property build period, 2020



Tadley North, Kingsclere and Baughurst had a larger percentage of dwellings built in the early 20th Century compared to Basingstoke and Deane as a whole, with 30.3% built before 1955, compared to 17.5% for the borough overall.

House prices and sales, 2004-2019



There were 135 home sales in 2019, similar to levels in recent years. This was 4.6% of the borough's house sales. One LSOA within the ward (B&D 004A) had a median house price in 2019 of £582,500, compared to the borough median of £305,000, and prices in this LSOA are consistently well above the borough average.

The number of unemployed benefit claimants peaked in July, August, September and October 2020.

Ward Map

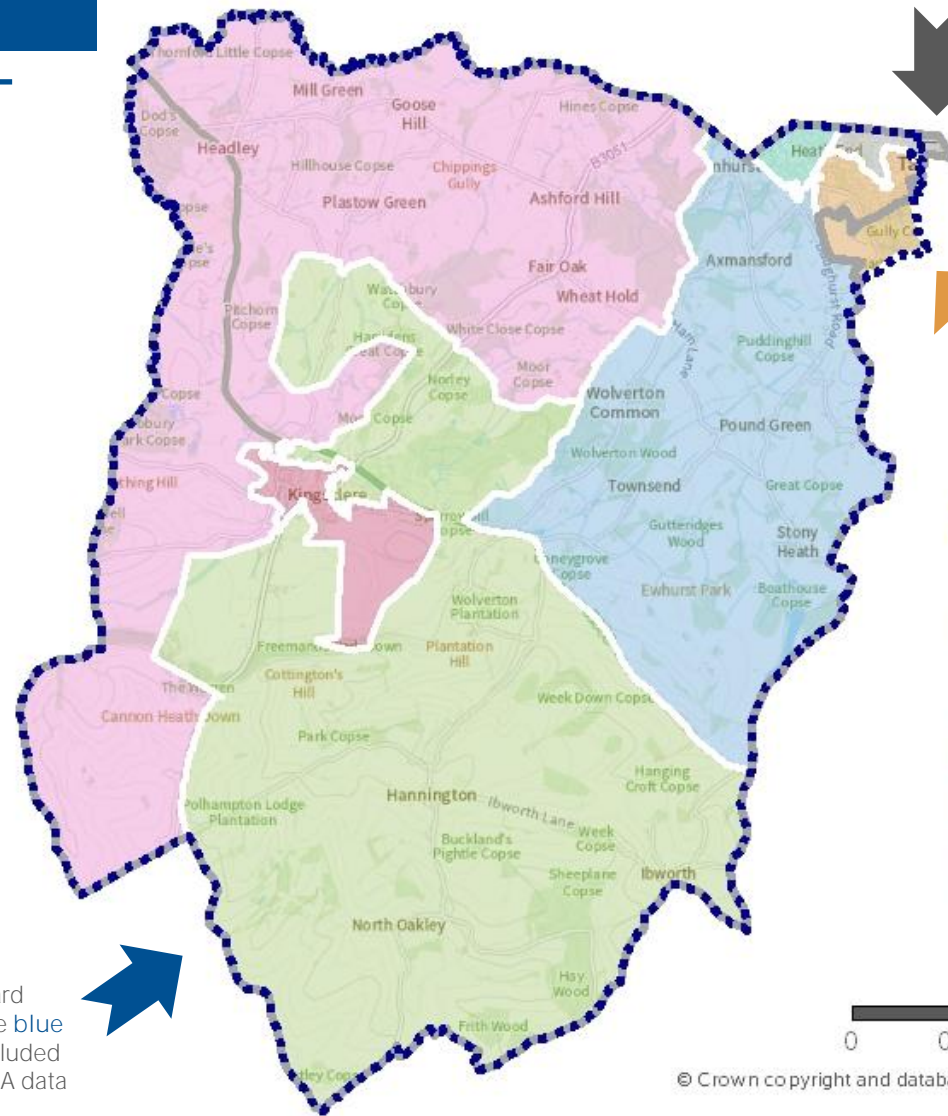
The ward boundary is shown in grey.

Due to ward boundary changes, some data is only available for the area covered by the output areas (OAs) and lower super output areas (LSOAs) that best fit the ward area. The best fit output area boundaries are shown surrounded by the **blue dashed line**. Tadley North, Kingsclere and Baughurst contains seven LSOAs and their best fit boundaries are shown with coloured backgrounds on the map.

An OA and LSOA is allocated to a ward if its population weighted centroid falls within the ward. This means that the Penney Way area (covered with grey horizontal lines) is not included within the ward's OA data. One LSOA (shown in **orange**) also includes part of Tadley and Pamber ward.
