

THE BASINGSTOKE AND DEANE BOROUGH COUNCIL
(OFF STREET PARKING PLACES) ORDER 2017

NOTICE IS HEREBY GIVEN that Basingstoke and Deane Borough Council (the Council), pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of the powers of the said County Council and in exercise of its own powers under Sections 1(1), 2(1) to (3), 4, 5, 32, 35 and 124 and Part IV of the Road Traffic Regulation Act 1984 (the Act), and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act has made the following Order:-

Title – This Order may be cited as The Basingstoke & Deane (Off Street Parking Places) Order 2017 (the Order)

The effect of the Order will be to –

1. To update the Order with new parking charges.
2. To include Loddon Parade within the Off Street Parking Places Order.
3. To revoke The Basingstoke & Deane (Off Street Parking Places) Order 2016.
4. To revoke the The Basingstoke & Deane (Off Street Parking Places) (Loddon Parade, Basing View) Order 2016.

Any person who desires to question the validity of the Order or of any provisions contained in the Order on the grounds that it is not within the powers of Sections 1(1), 2(1) to (3), 4, 5, 32, 35 and 124 and Part IV of the Road Traffic Regulation Act 1984, or on the grounds that any requirement of those Sections or of Parts I, II, III or IV of Schedule 9 to the Act or any requirements made under the said Part III of Schedule 9 have not been complied with in relation to the Order may, by 19th May 2017 make application for the purpose to the High Court
