ORDER 2018

The Basingstoke and Deane Borough Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of its powers under sections 1, 2, 4, 32, 35, 45, 46, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. The Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Loading and Unloading and Parking Places (Consolidation) Order 2018 shall be amended by the revocation of the plans specified in the Schedule 1 to this Order and the insertion of the plans specified in the Schedule 2 to this Order.
2. The Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Loading and Unloading and Parking Places (Consolidation) Order 2018 shall be amended by the revocation of Schedule 3 to the Order which shall be replaced by Schedule 5 to this Order.
3. The Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Loading and Unloading and Parking Places (Consolidation) Order 2018 shall be amended by the revocation of Schedule 6 to the Order which shall be replaced by Schedule 4 to this Order
4. Those Orders listed in Schedule 3 to this Order are hereby revoked.

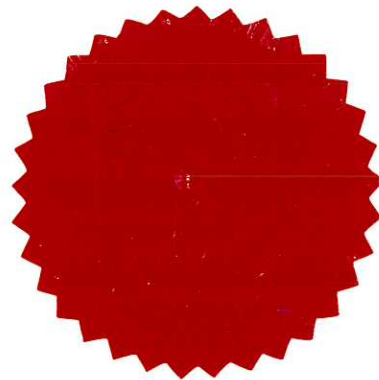
5. The effect of this order will be to include the provisions of the following Orders within the (Prohibition and Restriction of Waiting and Loading and Unloading and Parking Places (Consolidation) Order 2018 (Amendment No. 1) Order 2018:

- a) Basingstoke and Deane Borough Council (Packenham Road, Basingstoke) (Prohibition of Waiting) Traffic Order 2018 and
- b) Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Parking Places) (Various Roads) (No.2) Order 2017

This order updates charges and charging hours for Joices Yard car park as shown in Schedule 4 and updates charges for permit parking schemes as shown in Schedule 5.

6. This Order shall come into operation on 13 October 2018 and may be cited as the Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Loading and Unloading and Parking Places (Consolidation) Order 2018) (Amendment No. 1) Order 2018
