
The Basingstoke and Deane Borough Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of its powers under sections 1, 2, 4, 32, 35, 45, 46, 122 (1) and (2), 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. The Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Loading and Unloading and Parking Places (Consolidation) Order 2018 shall be amended by the revocation of the Plan specified in the Schedule 1 to this Order and the insertion of the Plan specified in the Schedule 2 and attached to this Order.

2. The effect of this Order will be to introduce the following parking controls:
Cufaude Lane, Basingstoke (Plan BE37) – No waiting at any time on the lengths of road as further detailed in plan BE37 specified in Schedule 2 and attached to this Order.

3. This Order shall come into operation on 25 January 2020 and may be cited as the Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Loading and Unloading and Parking Places (Consolidation) Order 2018 (Amendment No.9)(Cufaude Lane, Basingstoke) Order 2019
