

**BASINGSTOKE AND DEANE (OFF STREET PARKING PLACES) ORDER 2019  
(AMENDMENT NO 1) ORDER 2020**

Basingstoke and Deane Borough Council (hereinafter called "The Council") in exercise of its power under Sections 1(1), 2(1) to (3), 4, 5, 32, 35 and 124 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), and all other enabling powers, with the consent of the County Council of Hampshire in accordance with Section 39 (3) of the Act of 1984, and after consulting the Chief of the Police in accordance with Paragraph 20 (1) of Schedule 9 to the Act of 1984, hereby makes the following Order:

The Basingstoke and Deane (Off Street Parking Places) Order 2019 ("the 2019 Order") shall be varied by:


1. The removal of Alencon Link (The Malls) car park with regard to hours of charging and evening/overnight charges in Schedule 5 from the 2019 Order and as shown in Schedule 1 below and replaced with the details as shown in Schedule 2 below.
2. The removal of the plan entitled "Leisure Park – Drawing No 21" from the 2019 Order and replacing it with the plan annexed to this Order.
3. The addition of the following sub-clause to clause 4. of the 2019 Order:  
  
“(6) Where there is no charge for parking for a period within any Parking Place specified by name in column 2 of Schedule 1, a Parking Ticket must be obtained from a parking apparatus and displayed within the vehicle in accordance with paragraph (5) above as if it were a Parking Ticket issued on payment of a charge.”
4. The addition of the following words to the definition of "Parking Ticket":  
“or issued for display within a non-charging period”

The remainder of the order remains unchanged and continues to be in force.

**The effect of this Order will be:**

- a) To amend the period where an overnight charge commences in Alencon Link (The Malls) car park, from 19:00 hours to 18:00.
  - b) To include the addition of 5 disabled parking places in the Leisure Park car park
  - c) To provide that where there is no charge in a parking place, a free parking ticket is to be obtained from a parking apparatus and displayed within the vehicle.
5. This Order shall come into operation on 3 August 2020 and may be cited as the Basingstoke and Deane (Off Street Parking Places) Order 2019 (Amendment No 1) Order 2020.

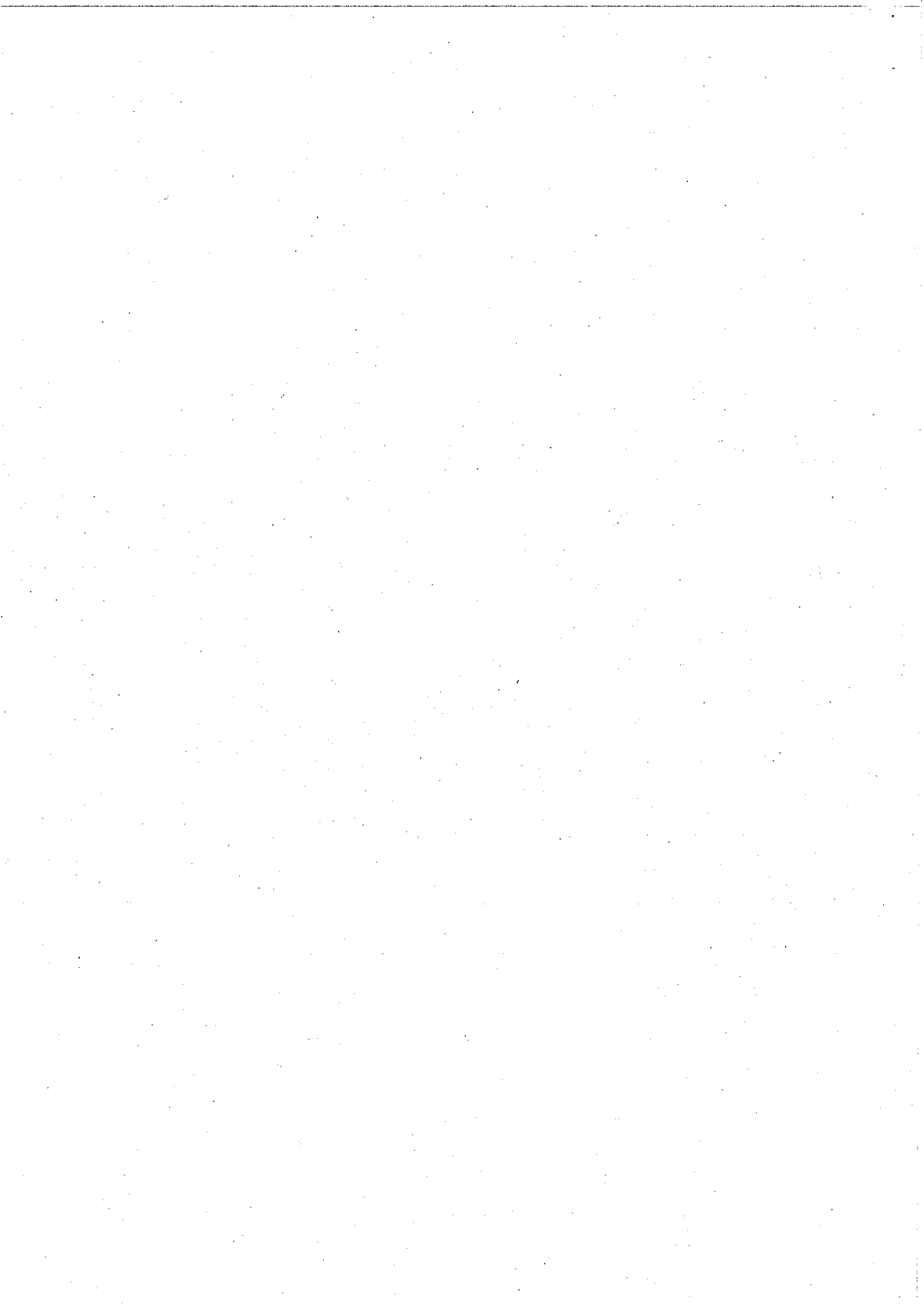

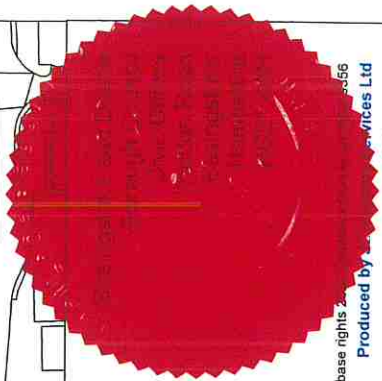
