**The Neighbourhood Planning (General) Regulations 2012 (as amended) (Regulation 16)**

Kingsclere Parish Council as the qualifying body has prepared a neighbourhood development plan, entitled Kingsclere Neighbourhood Development Plan 2011-2029, for their parish with the help of the local community. The neighbourhood plan sets out a vision for the future of the parish and planning policies which will be used to determine planning applications locally.

Basingstoke and Deane Borough Council is satisfied that the submitted Kingsclere Neighbourhood Plan complies with the relevant legal requirements and can therefore proceed to formal consultation and independent examination.

In accordance with the Regulations, the Borough Council is required to publicise the Neighbourhood Plan and supporting documents and invite comments.
