

BASINGSTOKE AND DEANE BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2021 (AMENDMENT NO.12) (CIVIC OFFICES, LEISURE PARK, LODDON MALL COURTYARD AND DOWN GRANGE) ORDER 2023

Notice is hereby given that The Basingstoke and Deane Borough Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of its powers under sections 1 (1), 2 (1) to (3), 4, 5, 45, 46, 122 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, has made the following Order:

Title:-

The title of the Order, will be the Basingstoke and Deane Borough Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2021 (Amendment No.12) (Civic Offices, Leisure Park, Loddon Mall Courtyard and Down Grange) Order 2023

The effect of the Order will be:

To amend the 2021 Consolidation Order to remove from the Order the parking restrictions in the Civic Offices, Leisure Park, Loddon Mall Courtyard and Down Grange car parks. The areas affected are as shown on plans AT49, AU42, AU43, AU48, AU49, AV42, AV43, AW42, AZ41 and BA43, which are annexed to the draft Order. It should be noted that the Council has made a further order to include those same areas within the Council's Off Street Parking Order. This is an administrative exercise only and the restrictions in these areas remain unchanged.

Date of operation:-

This Order will come into operation on 25 March 2023.

Application to the High Court:-

Any person who desires to question the validity of the Order or of any provisions contained in the Order on the grounds that it is not within the powers of Sections 1 (1), 2 (1) to (3), 4, 5, 45, 46, 122 and 124 of the Road Traffic Regulation Act 1984, or on the grounds that any requirement of those Sections or of Parts I, II, III or IV of Schedule 9 to the Act or any requirements made under the said Part III of Schedule 9 have not been complied with in relation to the Order may, by 6 May 2023 make application for the purpose to the High Court.
