



THE HAMPSHIRE (BASINGSTOKE AND DEANE BOROUGH COUNCIL)
(WINCHESTER STREET, MARKET PLACE, CHURCH STREET, CROSS STREET,
LONDON STREET, WOTE STREET) (STREET CLOSURE) ORDER 2026

Basingstoke and Deane Borough Council in exercise of its powers under Section 21 of the Town and Police Clauses Act 1847 and all other enabling powers and after consultation with the Chief Officer of Police hereby makes the following order for the prevention of obstruction of Winchester Street, Market Place, Church Street, Cross Street, London Street and Wote Street, during the Basingstoke Festival .

1. No person shall cause any vehicle including pedal cycles to proceed along the road referred to in Schedule 1 below.
2. Emergency vehicles and official vehicles shall be exempt from the restriction contained in Clause 1.
3. The penalty for contravening this Order is a fine not exceeding Level 3 on the Standard Scale.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. This Order will be effective on the date and at the times shown in Schedule 1 below.
6. This Order may be cited as The Hampshire (Basingstoke and Deane Borough Council) (Winchester Street, Market Place, Church Street, Cross Street, London Street, Wote Street) (Street Closure) Order 2026.
